This standard is suitable for:

Support and promote children's early education and development and be responsible for supporting the quality of learning and development in their setting.

Practitioners who aspire to be a leader within their early years setting.

Typical job titles could include room leader, deputy manager, assistant manager, senior practitioner, early years coordinator, play leader, key worker and nursery officer.

Work in partnership with the key person, colleagues, parents and/or carers or other professionals
